Introduction

This 2023 Body Worn Camera Report contains a summary of departments that submitted body worn camera program reports to the Illinois Law Enforcement Training and Standards Board (ILETSB). Each department overview includes narrative information and data provided by the department. Visual charts identify the ten (10) most frequent charges related to incidents; a single incident may have multiple charges. Departments reporting less than five (5) charges exclude visual charts. ILETSB is the repository for department reports.

One hundred eighty (180) law enforcement departments submitted body worn camera program reports for the period of January 1, 2023, to December 31, 2023, up from one hundred seventeen (117) last year. Categorically, one (1) forest preserve district, eight (8) campus law enforcement departments, twenty-three (23) sheriff's offices, and one hundred forty-eight (148) municipal law enforcement departments submitted reports.

Nine (9) law enforcement departments either do not use body worn cameras or implemented them in the year 2024. Therefore, this report excludes these departments:

Departments provide a brief overview, which includes the number of officers in the department, number of body worn cameras, and number of officers who use those cameras.

Technical Issues


Common technical issues include low battery life, cameras not charging, difficulty uploading footage, and cameras falling off the officer. Departments may list remedies to the issues.

Review Process

Departments report review policy on body worn camera footage.

Incidents

Departments report incidents when prosecutors use body worn camera footage. This section counts and lists incidents and offenses charged. Please note, one (1) incident may contain multiple offenses charged. Between January 1, 2023, and December 31, 2023, one hundred twenty-three (123) departments reported ninety-nine thousand five hundred thirty (99,530) incidents leading to one hundred twenty thousand nine hundred eighty-three (120,983) offenses charged. Fifty percent (50%) of offenses charged were the following ten (10) offenses:



Department Overview – Aledo Police Department

Aledo Police Department consists of six (6) full-time officers, three (3) part-time officers and one (1) auxiliary officer, using REVEAL D3 body worn cameras.

Technical Issues


Aledo Police Department reports issues with two (2) cameras splitting apart, multiple problems with cameras not turning on at activation, and not turning off when shut down. Due to this, Axon body worn cameras were purchased.

Review Process

Aledo Police Department's supervisors are authorized to review relevant recordings any time they are investigating alleged misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing a member's performance.

Incidents

Between January 1, 2023, and December 31, 2023, Aledo Police Department reports sixty-four (64) incidents leading to sixty-four (64) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Alton Police Department

Alton Police Department consists of sixty-two (62) officers who utilize seventy (70) body worn cameras.

Technical Issues


Alton Police Department reports zero (0) technical issues.

Review Process

Alton Police Department's supervisors ensure officers equipped with body worn cameras utilize them in accordance with policy and training. Monthly, patrol supervisors randomly review four (4) body worn camera recordings pertaining to subordinates under his/her responsibility. They document their review in a Guardian Tracking entry. Recordings are not reviewed indiscriminately for disciplinary purposes.

Incidents

Between August 1, 2023, and December 31, 2023, Alton Police Department reports one hundred ninety-one (191) incidents leading to one hundred ninety-two (192) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Arlington Heights Police Department

Arlington Heights Police Department's report does not provide department or body worn camera information.

Technical Issues


Arlington Heights Police Department reports zero (0) technical issues.

Review Process

Arlington Heights Police Department's report does not include a formal review process.

Incidents

Between January 1, 2023, and December 31, 2023, Arlington Heights Police Department reports one hundred twenty-two (122) incidents leading to two hundred nine (209) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Aurora Police Department consists of three hundred twenty-five (325) sworn officers who utilize three hundred twenty-five (325) body worn cameras.

Technical Issues

The Aurora Police Department reports few technical issues, with only a handful of cameras needing to be sent back for repairs/replacement. Additionally, a couple of fleet cameras were sent back and replaced. The main technical issue was the intermittent issues with Redaction Studio.

Review Process


The Aurora Police Department utilizes built-in software in Axon's evidence.com, called Axon Performance, to review body worn camera footage of officers and supervisors, ensuring their proper use and performance. The software is set to automatically select one (1) random video for each officer in a squad, for review monthly. The supervisor one rank above the rank of the officer creating the video, is responsible for these reviews. Any deficiencies in how the camera is utilized, worn, and functions is documented and then an email is directed to the officer or supervisor for correction.

Supervisors do not review recordings to search for violations of policy or law not related to a specific complaint or incident. Supervisors may, per policy, review body worn camera footage for formal or informal complaint, or encounter could result in a complaint, use of force encounters, as corroboration of evidence of misconduct, or viewed to correct substandard performance or highlight commendatory performance.

Department Overview – Aurora Police Department, Continued

Incidents

Between January 1, 2023, and December 31, 2023, Aurora Police Department reports seven thousand two hundred twenty (7,220) arrests leading to nine thousand nine hundred fifty-four (9,954) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Bannockburn Police Department

Bannockburn Police Department consists of eight (8) full-time officers, including the Chief of Police and ten (10) part-time officers who utilize eleven (11) body worn cameras.

Technical Issues


Bannockburn Police Department reports zero (0) technical issues.

Review Process

Bannockburn Police Department's supervisors review footage for quality control measures. Officers may review their own BWC videos for report writing and recall purposes.

Incidents

Between January 1, 2023, and December 31, 2023, Bannockburn Police Department reports thirteen (13) incidents leading to thirteen (13) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Bartonville Police Department

Bartonville Police Department consists of thirteen (13) sworn officers who utilize eight (8) body worn cameras. The detective, school resource officer, and CIERT/ILEAS officer each have an additional camera, for a total of eleven (11) WatchGuard body cameras.

Technical Issues


Bartonville Police Department reports issues with five (5) body worn cameras malfunctioning due to battery and locking clips issues. Installing new batteries and clips solved the issues.

Review Process

Bartonville Police Department's review process consists of all use of force incidents being reviewed by the Chief of Police. Every sixty (60) days the detective officer reviews at least one (1) taped event from each officer. The reviews ensure that the cameras are being used properly, any malfunctioning of equipment is addressed, and any feedback can be given to each officer.

Incidents

Between January 1, 2023, and December 31, 2023, Bartonville Police Department reports seventy-three (73) incidents leading to seventy-five (75) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Batavia Police Department

Batavia Police Department utilizes forty-one (41) body worn cameras. The department activated and deployed its body worn camera program on May 10, 2021. Getac was selected as the camera vendor and model BC-2 is the camera used by all officers during this annual report cycle.

Technical Issues


Batavia Police Department reports few occasions where there were issues with body cameras failing to sync to the squad cameras and failing to activate when expected. Also, the camera charging stations not connecting with the server which caused delays in charging and in uploads of videos. No loss of data was reported.

Review Process

Batavia Police Department supervisors are authorized to review relevant body camera recordings at any time, to include when they are investigating misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing an officer's performance. Monthly, supervisors randomly review ten (10) recordings pertaining to their area of responsibility to ensure that the equipment is operating properly and that officers are using the cameras appropriately and in accordance with policy and training.

Incidents

Between January 1, 2023, and December 31, 2023, Batavia Police Department reports one thousand two hundred twenty-three (1,223) incidents leading to one thousand four hundred seventy-one (1,471) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Bedford Park Police Department

Bedford Park Police Department consists of thirty-six (36) sworn officers who utilize thirty-six (36) Axon Body 4 body worn cameras.

Technical Issues


Bedford Park Police Department reports battery issues with the Axon Body 3 cameras.

Review Process

Bedford Park Police Department uses Frontline Quality Assurance Evaluations software and sergeant completes a body worn camera review once a month. The software randomly selects a body worn camera video for each officer's review. The evaluation lists the date, time and location for each event, and lists twelve (12) questions to ensure that each officer is following department policies. The sergeant attaches the link for each video reviewed so the officer can view the video, and then acknowledge the evaluation with their signature.

Incidents

Between January 1, 2023, and December 31, 2023, Bedford Park Police Department reports ninety-three (93) incidents leading to ninety-six (96) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Bensenville Police Department

Bensenville Police Department consists of thirty-six (36) sworn full-time officers and four (4) part-time officers who utilize forty-one (41) Motorola Solutions WatchGuard V300 body worn cameras (two (2) part-time officers share one (1) camera). Two (2) body worn cameras remain unassigned to be utilized as a spare if a camera malfunctions or has technical difficulties.

Technical Issues


Bensenville Police Department reports eight (8) technical issues. Of those reported issues, four (4) were sync issues with the 4RE system. Other issues include "bloating" or enlargement of the middle of batteries, Error 0342, sync issues, incorrect time stamp, and repeatedly powered down which were solved by replacement or system recovery reboot.

Review Process

On a monthly basis, supervisors review an event captured by their officer's body worn camera. This audit is to ensure that the body worn camera is operating properly and that officers are using the camera appropriately and in accordance with policy and training. The supervisor completes the Bensenville Police Department BWC Supervisor Monthly Audit form and reviews it with their officer. Those audits are then turned into the Body Worn Camera Administrator for review.

Incidents

Between January 1, 2023, and December 31, 2023, Bensenville Police Department reports three hundred twenty-five (325) incidents leading to six hundred nine (609) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Berwyn Police Department consists of one hundred twenty-two (122) full-time sworn officers who use a body worn camera each and fifty-seven (57) auxiliary officers who share thirty (30) body worn cameras.

Technical Issues


Berwyn Police Department does not report specific technical issues. There were four (4) body worn cameras that were sent out for repair or replacement due to technical issues. Most of the issues were remedied by restarting the cameras.

Review Process

Berwyn Police Department's supervisors perform monthly random reviews of body worn camera recordings which consist of one (1) incident's footage of each officer. Supervisors coordinate the selection of officers with one another to ensure there are no duplicate reviews. These reviews are documented on the "In-Car / Officer-Worn Camera Video Review" form which includes reviewing supervisor, date of review, officer being reviewed, date/time of occurrence, type of incident, policy compliance, compliance with the law, officer's safety, any necessary action/follow-up taken.

Incidents

Between January 1, 2023, and December 31, 2023, Berwyn Police Department reports three hundred sixty-one (361) incidents leading to three hundred ninety-nine (399) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Bloomington Police Department

Bloomington Police Department has one hundred twenty-eight (128) body worn cameras, used by all sworn personnel when required.

Technical Issues


Bloomington Police Department reports zero (0) technical issues.

Review Process

Bloomington Police Department's supervisors review footage on an as-needed basis, including calls for service, complaints, or other relevant issues. Supervisors also review a minimum of two (2) random videos per officer per month.

Incidents

Between January 1, 2023, and December 31, 2023, Bloomington Police Department reports one thousand four hundred ninety-five (1,495) incidents leading to three thousand sixty-seven (3,067) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Bond County Sheriff's Office

Bond County Sheriff's Office's report does not provide department or body worn camera information.

Technical Issues


Bond County Sheriff's Office reports zero (0) technical issues.

Review Process

Bond County Sheriff's Office's report does not include a formal review process.

Incidents

Between January 1, 2023, and December 31, 2023, Bond County Sheriff's Office reports thirtyone (31) incidents leading to thirty-one (31) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Bourbonnais Police Department

Bourbonnais Police Department consists of twenty-seven (27) sworn officers who utilize twenty-four (24) Getac Body Worn Cameras (model# BC-02).

Technical Issues


Bourbonnais Police Department reports minor technical issues including low battery life, video being uploaded in different usernames, and cameras not syncing to in-car cameras.

Review Process

Bourbonnais Police Department's supervisors review body worn camera videos of officers on their shifts to document training issues and policy compliance that should be addressed at their level. Administrators have the right to review body worn camera videos any time they are investigating alleged misconduct, reports of meritorious conduct or whenever such recordings would be beneficial in reviewing an officer's performance or a training exercise.

Incidents

Between January 1, 2023, and December 31, 2023, Bourbonnais Police Department two hundred eighty (280) incidents leading to two hundred eighty (280) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Burbank Police Department

Burbank Police Department consists of forty-seven (47) full-time police officers who utilize twenty (20) body worn cameras.

Technical Issues


Burbank Police Department reports that three (3) body worn cameras were shipped to the service provider for being defective. The technical issues encountered include camera displaying a SD card error code, camera stuck in boot sequence, and damaged internal component.

Review Process

Burbank Police Department's supervisors are authorized to review relevant body camera recordings any time they are investigating alleged misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing a member's performance. Supervisor of the recording member documents in the report or other documentation if the supervisor reviewed body worn camera recordings prior to completing the report or other documentation.

Incidents

Between May 3, 2023, and December 31, 2023, Burbank Police Department reports five hundred seventy-eight (578) incidents leading to one thousand two hundred thirty-two (1,232) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Burr Ridge Police Department

Burr Ridge Police Department consists of twenty-seven (27) officers who utilize twenty-seven (27) Axon Body 3 body worn cameras.

Technical Issues

Burr Ridge Police Department reports intermittent reboot issue while recording which led to incomplete video recordings. The camera was sent to the manufacturer for repair.

Review Process

Burr Ridge Police Department's patrol sergeant conducts monthly documented review of video data for every employee to assist in periodic assessment of performance and to determine whether the equipment is being properly used. Each watch includes at least two separate instances per employee.

Incidents

Burr Ridge Police Department's report does not include incidents data.

Department Overview – Carbondale Police Department

Carbondale Police Department consists of approximately sixty (60) sworn officers who utilize a body worn camera each.

Technical Issues


Carbondale Police Department reports zero (0) technical issues.

Review Process

Carbondale Police Department's supervisors, sergeants, lieutenants, and command staff review all body worn camera videos that contain any use of force to ensure adherence to laws and policy. Other videos are reviewed at random or when complaints arise.

Incidents

Between July 1, 2023, and December 31, 2023, Carbondale Police Department reports seven hundred seventy-two (772) incidents leading to one thousand one hundred forty-four (1,144) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Carol Stream Police Department

Carol Stream Police Department consists of sixty (60) officers who utilize sixty (60) WatchGuard Vista body worn cameras.

Technical Issues

Carol Stream Police Department reports battery charging issues requiring batteries replacement, docking issue that delayed uploading of data and software issues which required replacement of camera through the manufacturer.

Review Process

Carol Stream Police Department's supervisors randomly review recordings pertaining to their area of responsibility to ensure the equipment is operating properly and that officers are using the cameras appropriately and in accordance with training and department policy.

Incidents

Carol Stream Police Department's report does not include incidents data.

Department Overview – Carpentersville Police Department

Carpentersville Police Department consists of fifty-two (52) sworn officers who utilize fifty-two (52) body worn cameras.

Technical Issues


Carpentersville Police Department reports minor technical issues with low battery life of the cameras, which was resolved by internal programming and USB charging cords in the squads as well as the ability to swap out for a fully charged camera during the shift.

Review Process

Carpentersville Police Department's supervisors review a minimum of two (2) recordings per officer selected from the month being audited, ensuring that they were recorded in that month. The selection of recordings is conducted in a manner that promotes an equitable review of recordings from all officers. Supervisors document their review using the BWC Monthly Review electronically on My Frontline, BWC Audits. Supervisors do not review recordings for the sole purpose of searching for violations of department policy or law not related to a specific complaint or incident. If policy violations are observed by a supervisor, such policy violations are treated on a basis which neither enhances or diminishes any potential discipline.

Incidents

Between January 1, 2023, and December 31, 2023, Carpentersville Police Department reports four hundred twenty-two (422) incidents leading to four hundred twenty-two (422) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Champaign County Sheriff's Office

Champaign County Sheriff's Office utilizes fifty-six (56) VIEVU body worn cameras. The report does not include staff information.

Technical Issues

Champaign County Sheriff's Office reports minor wear and tear issues.

Review Process

Champaign County Sheriff's Office's Patrol Division Lieutenant, the Investigations Division Lieutenant, and the Administrative Support Lieutenant view at least four (4) videos, one (1) from each shift, and review them from a management standpoint of quality control. If an issue is discovered, the captain of the law enforcement division is contacted, and a determination is made for the best course of action to remedy the problem. Each week, the shift supervisors choose at least six (6) videos from their shift and review the videos from a supervisory standpoint for quality control. If an issue is discovered, which cannot be addressed at their level, they are advised to contact the patrol division lieutenant to determine the best course of action to remedy the problem.

Incidents

Champaign County Sheriff's Office's report does not include incidents data.

Department Overview – Champaign Police Department

Champaign Police Department consists of one hundred twenty-six (126) sworn officers who utilize a body worn camera each.

Technical Issues

Champaign Police Department reports following issues with body worn cameras:

- Officers misclassify footage resolved with further training and supervision
- SD card errors repaired in-house
- Camera synchronization failure
- Diminished battery life
- Three (3) Video import issues resolved by in-house staff trained in the video system
- Camera mount failure
- Two (2) cameras stopped recording remedied with a firmware update by manufacturer
- Camera shut down due to overheating

Champaign Police Department's sergeants randomly review body worn camera videos for each of their assigned officers to ensure policy compliance. 



Department Overview – Chicago Police Department

Chicago Police Department is the largest municipal police agency in Illinois with approximately eleven thousand five hundred (11,500) sworn officers. The Chicago Police Department is divided into two (2) offices: the Office of Operations and the Office of Constitutional Policing and Reform. The Chicago Police Department has prioritized officer worn camera deployment in the Office of Operations Patrol Districts and Units within the Special Operations Group. CPD maintains a pool of one thousand eight hundred (1,800) additional cameras to be assigned to sworn officers during deployments, special events, and temporary field duty.

The Chicago Police Department consists of twenty-two (22) patrol districts, as well as Area Community Safety Teams. These districts and teams are staffed by approximately seven thousand five hundred (7,500) sworn officers; all the officers are equipped with body worn cameras. There are another approximate eight hundred (800) body worn cameras assigned to the Mass Transit Unit, SWAT, Traffic, Detail Unit, Fugitive Apprehension, and Investigative Response teams. As of May 1st, 2023, approximately ten thousand (10,000) body worn cameras are utilized by the Chicago Police Department. Eight thousand two hundred (8,200) permanently assigned and one thousand eight hundred (1,800) utilized for temporary field deployments.

Technical Issues

Chicago Police Department reports that there have been no major technical issues with their cameras and are currently in the process of replacing their older cameras with new cameras of the same model.

Review Process


Chicago Police Department supervisors ensure:

- Department members use body worn cameras consistent with Chicago Police Department directives.
- A report is entered in a Chicago Police Department application whenever any member is unable to use the body worn camera or download digitally recorded data due to technical problems. This application is monitored by trained field technicians who respond to repair or replace any defective equipment; there are also a small number of cameras at each location that can be assigned to an officer on a temporary basis.
- An investigation is initiated when notified of a missing, lost, or damaged body worn camera.
- The distribution, charging, and uploading of the body worn cameras are consistent with Chicago Police Department directives.
- Officers who reviewed a body worn camera recording prior to writing an arrest report document this fact in the narrative portion of the arrest report prior to submitting the report for approval.
- The Watch Operations Lieutenant reviews at least one (1) random recording per watch to ensure Chicago Police Department policy is properly adhered to.
- For use of force incidents, all pertinent body worn camera videos are reviewed by the Watch Operations Lieutenant.
- District commanders/unit commanding officers, or their designee, receive weekly reports on officer body worn camera usage and the number of unmatched videos to ensure

compliance with Chicago Police Department policy.

Incidents

Between January 1, 2023, and December 31, 2023, Chicago Police Department reports thirtysix thousand five hundred sixty-four (36,564) incidents leading to thirty-seven thousand two hundred eighty-two (37,282) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Chicago Ridge Police Department

Chicago Ridge Police Department consists of thirty-one (31) sworn officers, who utilize thirty-one (31) Motorola V300 body worn cameras, that have been in use since 2023.

Technical Issues

Chicago Ridge Police Department reports that there were minor technical issues caused by a firmware malfunction which is under repair.

Review Process

Chicago Ridge Police Department's report does not include a formal review process. However, it is mentioned that all videos are retained for a minimum of ninety (90) days period.





The supervisor of the recording member document in the report or other documentation if the supervisor or the recording member reviewed body worn camera recordings prior to completing the report or other documentation.

Technical Issues

Country Club Hills Police Department reports two (2) technical issues.

Review Process

Country Club Hills Police Department's report does not include a formal review process.

Department Overview – Crestwood Police Department

Crestwood Police Department consists of thirty-four (34) sworn officers who utilize twenty-five (25) body worn cameras.

Technical Issues

Crestwood Police Department reports a few technical issues that were corrected immediately by Axon, with only a learning curve as the officers learned the procedures and the Body Worn Camera Act. Initial problem with battery life not lasting through shift was addressed by supplying charging cables in each patrol vehicle.

Review Process

Crestwood Police Department utilizes a program titled Body Worn Camera Audits through Frontline, to review body worn camera footage of officers and supervisors, ensuring their proper use and performance. Each month, the number of videos created for each police officer is entered into Frontline Quality Assurance Evaluation. Frontline shuffles the videos, randomly selects a video, and then a supervisor views the video in its entirety, to ensure that each officer is following the policy. Each supervisor one rank above randomly selects two (2) videos per officer monthly.

Any deficiencies in how the camera is utilized, worn, and functions is documented and then an email is directed to the officer or supervisor for correction. A command staff officer reviews and evaluates all supervisors.

Incidents

Crestwood Police Department's report does not include incidents data.

Department Overview – Crystal Lake Police Department

Crystal Lake Police Department utilizes sixty-nine (69) body worn cameras, of which sixty-five (65) are currently being utilized.

Technical Issues


Crystal Lake Police Department reported zero (0) technical issues.

Review Process

Crystal Lake Police Sergeants have permission to conduct video reviews, when necessary, but are required to select two random videos each month for mentoring and training purposes. The ranks above sergeant conduct administrative reviews of videos as necessary and in-line with our Response to Resistance Administrative Review Policy. Videos that are reviewed should have a note attached in Evidence.com specifying who watches the video and the reason.

Department Overview – Darien Police Department


Review Process

Darien Police Department's supervisors (patrol and investigations) periodically review their personnel's body worn camera footage. There is an Excel log sheet accessible to supervisors detailing each review performed. The date reviewed, type of recording (Axon or WatchGuard), time of incident, officer, vehicle number (if applicable), event category and comments (whether there were issues and the remedy) are all columns that can be answered.

A random video review system was purchased by the Darien Police Department in 2024 to ensure that videos reviewed by supervisors are selected randomly and autonomously.





Technical Issues

Des Plaines Police Department reported a few issues with their body worn cameras. One (1) camera needed to be sent in for repair due to the systems needing to be re-flashed with software, and a few cameras were not recording which was fixed by a simple hard restart.

Review Process

Des Plaines Police Department supervisors have access and the responsibility to review the body worn camera videos. Labeling, redacting, and duplicating of any recordings is done by the support services manager, operations deputy chief, support services deputy chief, and chief of police. Recorded files are viewed: upon approval by a supervisor as part of an official investigation, pursuant to a lawful process, by media personnel, in compliance with public records request, by the recording officer's field training officer for training purposes, and/or by any detective or investigator involved in the investigation of a matter.

Incidents

Des Plaines Police Department's report does not include incidents data.

Department Overview – Downers Grove Police Department

Downers Grove Police Department consists of seventy-one (71) sworn officers, and possess seventy-seven (77) body worn cameras, of which sixty-three (63) are assigned to officers.

Technical Issus

Downers Grove Police Department reports that there were four (4) reported technical issues with their body worn cameras. The primary issue that was reported was cameras were not pairing with vehicle computers and turning off on their own. The other issue reported was a reset error.

Review Process

Downers Grove Police Department's report includes a body worn camera review process as follows:

- Department members utilize the officer-worn body camera consistent with police department directives.
- Recordings are assigned in Evidence.com to the member who created the recordings.
- A civilian staff member is assigned to monitor and review all the digital files within Evidence.com to ensure they are properly identified and categorized. When a digital file is not in compliance, the officer and their supervisor are made aware of the situation so that it can be remedied.
- An investigation is initiated when a staff member determines that an officer-worn body camera is missing, lost, or damaged.
- The distribution, charging, and uploading of the officer-worn body cameras and their digital files are consistent with police department directives.
- Officers who reviewed an officer-worn body camera recording prior to writing a report document this information in the narrative portion of the police report.
- Quarterly, supervisors review both officer-worn body camera and in-car camera recordings, if applicable. Supervisors review four (4) incidents per officer per quarter. If an officer is assigned a squad car equipped with an in-car camera, the reviews shall include two (2) officer-worn body camera recordings and two (2) in-car camera recordings. If an officer is not assigned a squad car equipped with an in-car camera, the review shall be of four (4) officer-worn body camera recordings. The reviews are performed to ensure officers utilize the body worn cameras in compliance with police department policy and procedures. This review process is documented on a standardized form and saved for future reference.

Incidents

Downers Grove Police Department's report does not include incidents data.

Department Overview – DuPage County Sheriff's Office

DuPage County Sheriff's Office consists of one hundred five (105) sworn law enforcement personnel who utilize an Axon body worn camera each.

Technical Issues



Review Process

DuPage County Sheriff's Office body worn camera program is managed by sergeant and civilian personnel. Both individuals organize and manage the Evidence.com data, the labeling of videos, citizen shared evidence, sharing videos with the state attorney's office, and conducting FOIA and subpoena requests. Axon Performance randomly selects a video and then plays it for the supervisor. After the review, the supervisor can add comments or click several predetermined responses such as no issues/concerns observed, late activation, poor video/poor sound, or unsatisfactory behavior. The deputy then gets an email response with the results of the review. Each team supervisor is required at minimum to review four (4) videos from their team per month.

Incidents

Between January 1, 2023, and December 31, 2023, DuPage County Sheriff's Office reports six hundred ninety (690) incidents leading to seven hundred eighteen (718) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – East Moline Police Department

Lake County Sheriff's Office's supervisory staff conduct biannual reviews of two (2) random videos per subordinate to ensure compliance with policy and state law, as well as to identify any technical issues. Any technical glitches are promptly reported to the training division, while policy violations are addressed through disciplinary and complaint procedures.

In the event of an external or internal complaint, supervisory personnel have access to review relevant body worn camera footage. Moreover, the Office of Professional Standards oversees all reviews and conducts periodic checks and audits.

Between January 1, 2023, and December 31, 2023, Lake County Sheriff's Office reports four hundred fifty-two (452) incidents leading to four hundred eighty-four (484) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Department Overview – Lake Forest Police Department

Lake Forest Police Department consists of thirty-nine (39) sworn officers who utilize forty (40) Axon Body 3 body worn cameras; one (1) is used as a spare.

Technical Issues

Lake Forest Police Department reports four (4) technical issues consisting of recording issue, charge issues which were solved by cameras being replaced.

Review Process

Lake Forest Police Department's supervisors access and review body worn camera footage for performance assessments, compliance checks, as well as random checks and to investigate misconduct complaints. During these inspections supervisors check to make sure officers are operating their body worn cameras in accordance with the Body Worn Camera Act. Additionally, supervisors review if officers are properly documenting body worn camera use in police reports.

Shift supervisors conduct random spot checks of body worn camera videos for members of their shift.

Incidents

Oak Lawn Police Department's report does not include incidents data.

Department Overview – O'Fallon Police Department

O'Fallon Police Department consists of forty-nine (49) sworn officers who utilize forty-seven (47) Axon 3 body worn cameras. Body worn cameras are issued to every officer except for two (2) officers deployed to external task forces; administration is also issued body worn cameras.

Technical Issues







All issues were resolved by replacement of body worn cameras.

Review Process

Oswego Police Department's shift supervisor does a review of two (2) videos each month. The reviews are documented in Frontline and the officers are notified that their video has been reviewed.

Oswego Police Department's report does not include incidents data.

Department Overview – Ottawa Police Department

Ottawa Police Department consists of thirty-nine (39) sworn officers who utilize thirty-nine (39) body worn cameras.

Technical Issues


Ottawa Police Department reports one (1) technical issue with camera battery life. The body worn camera was sent in for service.

Review Process

Ottawa Police Department's Captain of Patrol reviews at least six (6) random videos per month that have been uploaded to I-Crimefighter or the AXON database. Supervisors are authorized to review relevant recordings any time they are investigating alleged misconduct or reports of meritorious conduct or whenever such recordings would be beneficial in reviewing a member's performance. The supervisor of the recording member documents in the report or other documentation if the supervisor or the recording member reviewed body worn camera recordings prior to completing the report or other documentation.

Department Overview – Palatine Police Department

Palatine Police Department consists of one hundred eight (108) sworn officers who utilize one hundred eight (108) Axon Body Worn 3 body worn cameras.

Technical Issues

Palatine Police Department reports zero (0) technical issues.

Review Process

Palatine Police Department's patrol supervisors (three (3) commanders and nine (9) sergeants) review a minimum of ten (10) videos recorded by Axon equipment each monthly. This review process is accomplished through the Axon Performance program, which randomly assigns the requesting supervisor a video that has been recorded by the officers. The purpose of this review is to ensure that equipment is operating properly and that officers are using the cameras appropriately and in accordance with the policy and training.





Parkland College Police Department reports technical issues with body worn cameras including unprompted activation of recordings, battery not holding charge which were resolved by software upgrade, and replacement by the manufacturer respectively.

Review Process

Parkland College Police Department's sergeants review at least one (1) randomly selected file a month, documented through a Body Cam Monthly Check spreadsheet. Parkland police command staff may periodically review records to identify training needs, ensure officer compliance to policy, fulfil FOIA requests. If a complaint is made and a body worn camera recording exists, a supervisor immediately ensures that the recording is secure. The recording is copied to DVD or USB storage device and given to the chief for review.

Incidents

Parkland College Police Department's report does not include incidents data.

Department Overview – Paxton Police Department

Paxton Police Department consists of eight (8) full-time officers and two (2) part-time officers who utilize eight (8) body worn cameras.

Technical Issues



Department Overview – Pingree Grove Police Department

Pingree Grove Police Department consists of fourteen (14) sworn officers (thirteen (13) full-time officers and one (1) part-time officer) and three (3) non-sworn personnel who utilize nineteen (19) body worn cameras.

Technical Issues

Pingree Grove Police Department reports zero (0) technical issue.

Review Process



Department Overview – Prairie Grove Police Department

Technical Issues

Prairie Grove Police Department reports battery charge issue. It was resolved by charging the body worn camera periodically during the shift or swapping out the camera for a fully charged camera.

Review Process

Prairie Grove Police Department's supervisors are authorized to review relevant recordings when investigating alleged misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing an officer's performance.

Incidents

Prairie Grove Police Department's report does not include incidents data.

Department Overview – Riverwoods Police Department

Riverwoods Police Department consists of nine (9) full-time officers and eight (8) part-time officers who utilize seventeen (17) Axon Body 4 body worn cameras.

Technical Issues

Riverwoods Police Department reports zero (0) technical issues.

Review Process

The Riverwoods Police Department's supervisors are authorized to review relevant recordings any time they are investigating alleged misconduct or reports of meritorious conduct or whenever such recordings would be beneficial in reviewing a member's performance. On a bimonthly basis, supervisors randomly review one traffic stop recording and one non-traffic related recording of subordinates under his/her responsibility to ensure that the equipment is operating properly and that officers are efficiently using the cameras appropriately and in accordance with policy, state laws and training. These bi-monthly reviews are documented on a supervisory review form.

Riverwoods Police Department's report does not include incidents data.

Department Overview – Rock Island Police Department


Skokie Police Department reports several issues with the body worn cameras such as self-reset while recording, Error Code 1004 while in dock, heating, self-switch from sleep mode to ready mode, display errors, flashing yellow lights, issue with event button, broken magnet and pocket mounts, and issue connecting with Axon Evidence.com for video uploads. The body worn cameras were replaced by Axon and the issue with video upload was resolved by undocking and redocking the camera.
